### **DIRECTIONS & HOTELS (Restaurant list will be provided later)**

The hall is located about 9 miles North of Pottstown (take PA Rt. 663 to East Greenville then left on Main St. Go about 1 mile then right on 4<sup>th</sup> St.). Access to the show is easiest by taking the Rt. 663 exit (Quakertown exit) off of PA Turnpike Northeast Extension I-476. Then go about 4 miles on Rt. 663 to East Greenville. Then turn right on to Main Street (Rt. 29) for about 1 mile and then turn right on to 4<sup>th</sup> Street and see the fire hall at the bottom of the street. Newer hotels are available at the Quakertown exit and include: Hampton Inn, Holiday Inn Express, Springhill Suites by Marriot, and Quality Inn and Suites.
